Dear Senators:

I am writing in regard to the nomination of City Court Judge Thomas Marcelle to serve as a District Judge on the U.S. District Court for the Northern District of New York for several reasons.

The Article in the Troy Record dated October 12, 2018 states:

Prior to joining the court, Marcelle served as Chief Counsel to the Albany County Sheriff's Office and Albany County Attorney, here he oversaw the litigation of civil matters and prosecution of criminal matters. (No dates are given.)

Marcelle also had a long prestigious career in private practice focused on constitutional litigation, with focus on election and constitutional issues.

He also served as a Trial Attorney in the Civil Rights Division of the U.S. Department of Justice, responsible for enforcing the Civil Rights of Institutionalized Persons Act.

As Thomas Marcelle has been nominated for the Federal Judgeship for the Northern District of New York and the fact that he was Chief Counsel to the Albany County Sheriff's Office and the Albany County Attorney's office he had to know about the following:

I would refer you to my website, www.justice4ny.com/scoops (Scoop 60 - A letter to the Albany County Executive – corruption dated December 17, 2018) detailing the corruption in the Albany County Criminal Courts and the Albany County Family Court. I have documented where litigants are being deliberately tortured (denied sleep and food for days and other actions), denied their constitutional right to counsel, yet alone, competent assistance of counsel, where litigants are being denied their statutory right to a jury trial, where ADA's are allowed to commit perjury by testifying under oath and that criminal trials are being fixed by the judges, public defenders and the district attorney's office just to start with. Everything is verifiable using court documents, transcripts and other documents.

That after I sent the letter dated December 17, 2018 concerning the corruption, including torture, it was reported on December 29, 2018 that a federal suit was filed claiming the guards at the democrat-controlled Albany County Jail would deliver unusual and

confusing commands and when the inmates got it wrong, the guards would punch, kick and taze the inmates.

The lawsuit also alleges the guards would insert their batons in the young men's rectums. Also stating that the inmates would spend weeks, months or years in isolation. These inmates are all under the age of 22. Just google: "Albany County Sheriff's Office named in Federal Lawsuit" for full article.

Albany County has been stripping our veterans, their family members, blacks and other minorities of their rights, including but not limited to, their right to counsel and jury trials and being tortured by the police. As Mr. Marcelle oversaw the litigation of civil matters and the prosecution of criminal matters in Albany County, he had to be aware of the illegal actions being taken against litigants in order to obtain convictions.

As he was Chief Counsel to the Albany County Sheriff's office he knew or should have known about the horrific and unsanitary conditions in the Albany County Jail as more fully documented in my letter to Mr. McCoy and the recent article in the newspaper.

As Mr. Marcelle claims to be an expert in Constitutional law. Maybe he can explain why litigants in New York State, including our veterans and/or their family members, are being tried, convicted and sentenced to jail in closed court proceedings and denied their Constitutional Rights to a public trial and to a jury trial. In many cases, they are being deliberately denied counsel, yet alone, competent assistance of counsel. www.justice4ny.com/scoops (Scoop 02 No Right to a Public Trial when facing imprisonment; Scoop 05 Right to Jury trial in Family Court in NY; and Scoop 34 Judges, Public Defenders & Albany DA conspire fix cases.) Also Scoop 55 has a \$5,000 challenge concerning the above.

Second, Mr. Marcelle has a focus on election and constitutional issues. New York State is involved in fixing elections in favor of the democrats. In New York State you **do not** need proof of citizenship in order to vote, just proof of identity. According to the form: For Identification – You must make 1 selection

Verifying your identity (NOTICE: They are only verifying identity. They are NOT VERIFYING IF THEY ARE A CITIZEN OF THE UNITED STATES and can legally vote! How many illegal aliens voted in the last election because they can get away with it because there

are no checks and balances to make sure **ONLY** United States citizens are voting and no one is investigating voter fraud as the democrats make sure you cannot get the proof!) If you are of legal age to vote and you do not have either a NYS driver's license or a social security number, there is a 99.9% chance they are NOT a United States citizen. In order to get either a driver's license or a social security number, you have to have proof of citizenship and date of birth, and do not need to be a US citizen to get either one. Why should my vote be taken away from me by a person who is not a citizen of the United States? Why isn't this being investigated?

There are links to all court documents in my letter that support my statements. Further, I am offering \$5,000 to anyone who can produce the evidence that was stated in court decisions and orders. Two of my challenges and rules in my "Scoop" 56 deal directly with the corrupt district Attorney's office and judges and the Albany County Attorney's office was fully aware of this and did nothing.

As for the Sheriff's Department, in my letter to the Albany County Executive, I have fully documented lawsuits that detail the unsanitary mold and other infestations in the Albany County Jail. (Scoop 60). At least two suits were filed years apart alleging the same mold infestation. One being one I prepared.

Mr. Marcelle should be denied his appointment to the US District Court for the Northern District of New York as his positions with Albany County he had to be aware of the above and of the deliberate deprivation of Constitutional and Statutory rights and he did nothing about it. He will not protect constitutional rights to due process and equal protection of the law as a Federal judge. He believes his first obligation would be to the corrupt government officials.

As a final note, I would seriously doubt any investigation by the FBI concerning the above. The FBI is there to protect the corrupt New York State officials and cover up their illegal actions as more fully documented in my "Scoop 11" FBI - protecting the democrats and illegal imprisonments and my "Scoop 23" FBI, State & Albany county officials in attempted murder plot at www.justice4ny.com/scoops. They also refused to investigate a company called Yodle that illegally records phone calls that they are not a party to and are allowing Yodle to defraud small businesses out of tens of millions of dollars each year with its advertising schemes (Scoop 08).
